LOCAL LAW NO. 07-2023

A LOCAL LAW TO AMEND CHAPTER 215 OF THE CODE OF THE VILLAGE OF CROTON-ON-HUDSON REGARDING SPEED LIMITS

Be it enacted by the Board of Trustees of the Village of Croton-on-Hudson as follows:

Section One. Chapter 215, Vehicles and Traffic, of the Code of the Village of Croton-on-Hudson is hereby amended to read as follows:

§ 215-5 Speed Limits.

The maximum speed at which vehicles may proceed on or along any streets or highways within the Village is hereby established at 30 25 miles per hour, except that the speed limit for vehicles proceeding on or along those streets or parts of streets described in Schedule II (§ 215-50) shall be as indicated in said schedule.

Section Two. Chapter 215, Vehicles and Traffic, of the Code of the Village of Croton-on-Hudson is hereby amended to read as follows:

§ 215-50 Schedule II: Speed Limits.

In accordance with the provisions of § 215-5, speed limits other than 30 25 miles per hour are established as indicated upon the following streets or parts of streets:

Section Three. Severability

If any section, subsection, clause, phrase or other portion of this Local Law is, for any reason, declared invalid, in whole or in part, by any court, agency, commission, legislative body or other authority of competent jurisdiction, such portion shall be deemed a separate, distinct and

independent portion. Such declaration shall not affect the validity of the remaining portions hereof, which other portions shall continue in full force and effect.

Section Four. Effective Date

This local law shall take effect immediately upon filing in the office of the New York State Secretary of State in accordance with section 27 of the Municipal Home Rule Law.
