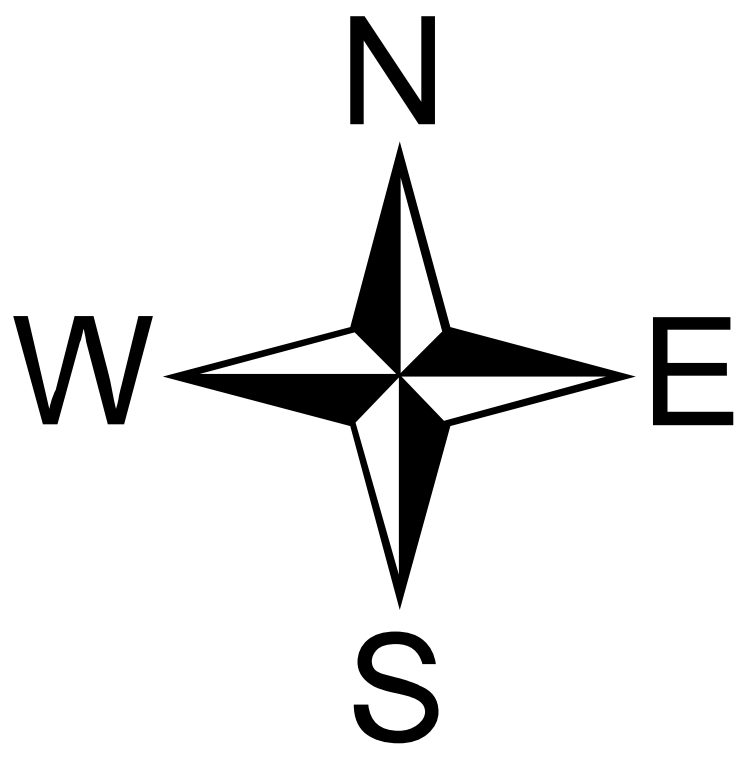
Local Law Introductory No. 7 of 2024 has been drafted to enact the Indian Brook-Croton Gorge Watershed Protection Overlay District. Since the Conservation Action Plan was completed in 2007, the five municipalities which are part of the overlay district have worked together to draft regulations which can be adopted in each municipality to protect the watershed and limit resource degradation.

This legislation will enact additional protective buffers around wetlands and waterbodies, prohibit uses in the overlay district which pose a higher risk of contamination and provide additional protection for the Village's wellhead, the primary source of drinking water for Village residents.
