16	WHEREAS, The Village of Estero was incorporated on December 31, 2014; and

29	Section 1. The Code entitled "Code of Ordinances of the Village of Estero, Florida,"
30	published by Municipal Code Corporation, consisting of chapters 1 through 36, each inclusive,
31	is adopted.

33	Section 2. All ordinances of a general and permanent nature enacted on or before June
34	16, 2021, and not included in the Code or recognized and continued in force by reference
35	therein, are repealed.
36	
37	Section 3. The repeal provided for in section 2 hereof shall not be construed to revive
38	any ordinance or part thereof that has been repealed by a subsequent ordinance that is repealed
39 40	by this ordinance.
40	Section 4. Unless another penalty is expressly provided, every person convicted of a
42	violation of any provision of the Code or any ordinance, rule or regulation adopted or issued
43	in pursuance thereof shall be punished by a fine not exceeding \$500.00, a definite term of
44	imprisonment not to exceed 60 days, or any combination thereof. Except as otherwise provided
45	by law or ordinance:
	•

(i) with respect to violations of this Code that are continuous with respect to time, each day that the violation continues is a separate offense; and with respect to violations that are not continuous with respect to time, each act constitutes a separate offense. The imposition of a penalty does not prevent suspension or revocation of a license, permit or franchise or other administrative sanctions.

Violations of the Code that are continuous with respect to time are a public nuisance and may be abated by injunctive or other equitable relief. The imposition of a penalty does not prevent injunctive or other equitable relief. The penalty provided by this section, unless another penalty is expressly provided, shall apply to the amendment of any Code section, whether or not such penalty is reenacted in the amendatory ordinance. Nothing in this section shall be construed to prohibit the Village from prosecuting any violation of the Code by means of a code enforcement system established pursuant to the authority of F.S. Ch. 162.
