Agenda Item:

Final Budget Amendment to close out Fiscal Year 2020/2021.

Resolution 2021-23 a resolution of the Village Council of the Village of Estero, Florida, Approving the final budget amendment of the fiscal year 2020/2021 to align certain budgeted line items within the General Fund and the Capital Improvement Fund.

Description:

Within the General Fund, eight line items were spent above the approved budgeted amounts. Within the Capital Improvement Fund there was one line items spent above the approved budgeted amount. While this level of budgetary control is within guidelines that do not require an appropriation, it is best practice to seek legislative action to ensure that no individual department within each fund remains overspent at the end of a fiscal year's activities.

Action Requested:

Adopt Resolution No. 2021-23.

Financial Impact:

NO additional appropriations are necessary to complete this amendment. Transfers to deficient account line items will be increased from budgeted line items with sufficient remaining budgeted dollars.
