A RESOLUTION OF THE PLANNING COMMISSION OF THE CITY OF FAIRVIEW, TENNESSEE, RECOMMENDING THE APPROVAL OF A REZONING REQUEST FROM RS-40 (SINGLE FAMILY RESIDENTIAL) TO RS-15 (SINGLE FAMILY RESIDENTIAL DISTRICT) FOR THE ENTIRETY OF TAX MAP 022 PARCEL 040.00, TOTALING 62.53 (+/-) ACRES LOCATED AT 0 HORN TAVERN ROAD. JAMES M. MOORE.

<u>WHEREAS</u>, the applicant, Alex Becker (EcoTerra, LLC.), is requesting approval of a rezoning from RS-40 (Single Family Residential District) to RS-15 (Single Family Residential District) for the entirety of Tax Map 022 Parcel 040.00 totaling 62.53 (+/-) acres of property located at 0 Horn Tavern Road; and

WHEREAS, this project has been given the project number #RZN-25-0004; and

<u>WHEREAS</u>, THE CITY OF FAIRVIEW MUNICIPAL PLANNING COMMISSION considered project #RZN-25-0004, submitted by Tim Mangrum, the applicant, at its regular meeting on December 9th, 2025; and

WHEREAS, the 2040 Fairview Forward Plan identifies this property as being within the New Residential-Medium Neighborhood Future Land Use classification. This future land use classification notes the appropriate land use as Single-Family Detached Residential. The New Residential-Medium Neighborhood Future Land Use Classification lists three (3) zone districts as appropriate. These zone districts are RS-40, R-20 with PUD, and a new district that would permit traditional neighborhood development.
