

**ORDINANCE NO. 2026-08**

**AN ORDINANCE FOR AN AMENDMENT TO THE CITY OF FAIRVIEW, TENNESSEE, BUDGET  
FOR FISCAL YEAR 2025 – 2026 BUDGET**

**Be it Ordained by the City of Fairview, Tennessee as follows:**

**WHEREAS**, the Board of Commissioners of the City of Fairview, Tennessee, have determined that the Budget for Fiscal Year 2025 – 2026 (beginning July 1, 2025, and running through June 30, 2026) should be amended to reflect the final expenditures for the Fiscal Year, and

**WHEREAS**, the Board of Commissioners of the City of Fairview, Tennessee adopted the fiscal year 2025 – 2026 budget by passage of Ordinance Number 2025-09 on June 5, 2025.

**WHEREAS**, pursuant to the Tennessee State Constitution, Article II, Section 24, no public money shall be expended except pursuant to appropriations made by law, and

**WHEREAS**, pursuant to Tennessee Code Annotated § 6-56-209, the Board of Commissioners has the authority to authorize the Finance Director to transfer money from one appropriation to another within the same fund, and

**NOW THEREFORE BE IT ORDAINED BY THE CITY OF FAIRVIEW, TENNESSEE  
THAT CHANGES BE MADE TO THE FISCAL YEAR 2025-2026 BUDGET AS FOLLOWS:**

Section 1. Ordinance 2025-09 is hereby amended to include the following revenues and appropriations.
