Dear Ellen,

How're you doing? We hope well!!

Thanks for so many times during our 12+ years in Falmouth being helpful to us as we worked our way into the community, after coming from your old stomping grounds in California's Silicon Valley. We always appreciate your willingness to many times accept our teasings and funfoolishments when we've stopped by town HQ for meetings (or bill-payings! Ugh!).

The help we need this time is to whom at the town should a letter be given in support of OceanView at Falmouth's current plans and applications to remodel-and/or-newly-construct and upgrade sections of facilities and living units at OV, including adding several dozen apartments to bring new residents into our community. So..., please pass this letter along to the appropriate town officials who would be professionally interested in our points of view on what we consider to be an overall improvement of where we live.

As background: For our later retirement years, a half-dozen years ago Sue & I moved from a home on Paddock Way, to a nice apartment at OceanView in Falmouth. We came to OV expecting a safe, comfortable, secure, well-maintained and well-managed senior-living facility. Our expectations have been more than met, and we have developed and enjoy friendly relationships with many welleducated interesting pals and neighbors. Beyond ourselves, our primary interest is helping bring high-quality music performances to OceanView...., and among residents we are considered a driving force in each month arranging, promoting and presenting two or more concerts at OV that are enthusiastically self-sponsored by our having built a happy participating cadre of almost 200 residents. From the beginning when we proposed undertaking this volunteer mission, OV's owner, John Wasileski has been super-supportive (Hoo-Ray for that encouragement!!). Being musicians ourselves (Sue a "pro", as you know), we are fortunate to enjoy good personal relationships with well more than half of the individual members of the Portland Symphony, many who also perform with and have introduced us to Boston-area musicians with Boston Pops and Boston Symphony Orchestra experience. We are dedicated as uncompensated individuals to paying high honorariums and bringing as many of those musicians as possible to perform at OceanView; likewise bringing to OV many chamber-music players from quality Maine Festival ensembles..., including faculty and advanced students from USM's Osher School of Music.

Considering our interest in high-quality music performances at OceanView, we consider two aspects of OceanView's current plans to upgrade and expand as especially attractive. First, of course, will be up to 50 new future pals being able to move into apartments in the proposed buildings. "People" are the lifeblood of living at OceanView, so getting to know "More People" will, we predict, be of significant added value to Sue's and my future later-life experiences. Of course, we look forward to some of those joining with us at concerts that we make happen in the future.

One aspect of the proposed overall expansion/replacement plan submitted to Falmouth authorities is especially attractive to Sue and me. The proposal includes significant enlargement of the community space in Blueberry Commons area of OV. We understand that the improved room will be able to hold maybe 200 people. Do we look forward to presenting concerts to larger audiences in the enlarged room? -- You Bet We Do!! That this enlargement was visualized by OV was a fantastic and delightful surprise to us; how brilliant! We have proposed that expansion of this BBC community room (that's what it's called by residents) include installation of a low stage (maybe seven or so inches higher than the floor) that would be large enough to hold double-quartets of eight musicians; it obviously would also be extra useful for general meetings, allowing better sightlines of speakers to OV residents (some of whom, including yours truly, occasionally incur neck discomforts). Residents with walkers in the currently existing lodges will benefit since additional group activities for larger assemblies can be more easily accessed while staying indoors. We are assured that our suggestion is receiving high-level consideration.

In discussions with some of our pals, we also have been especially impressed with aspects of the proposal regarding underground garages. Well-designed living-unit buildings built upon currently-paved parking areas --the new units constructed with underground parking-- are undoubtedly a win-win visual tradeoff (although it's a lose-lose tradeoff to Maine's winter snowstorm gremlins who want us to endure shoveling duties to get our vehicles back on the road --So including the garages is a Ha!Ha! to those nature scoundrels!). Obviously, the decision to create more underground parking is way better than just adding buildings and paving over additional land spaces with less-than-attractive whiteline-painted outside parking spaces.

We need to mention that others of our pals have praised that the proposed-plans will result in the installation of more solar units (although candidly, we are personally concerned about our nation's over-dependency on too many such units, lest the Chinese secretly have installed "turn-off-switches" as unconventional war-attack mechanisms). Nonetheless, we observe that the overall OV community is highly supportive of OceanView Management's commitment to solar energy sources.

Anyway, perhaps we've rambled on a bit with this letter......, but please understand that Sue and I strongly endorse the current proposed overall plan submitted by OceanView to the Town of Falmouth. We think moving forward as proposed will be good for OceanView, good for us....., and good for the wider Falmouth community.

Dear Members of the Falmouth Town Council,

We have been neighbors with Ocean View Retirement Community for the past twenty-eight years. We live next door on Falmouth Road.

OceanView is a big part of our lives, and we are grateful. I'd like to share a bit about our neighbors.

When our children were young they believed they had dozens of grandparents from spending so much time there. If one of them was not having a great day they might walk over and visit with friends at Falmouth House, they were received with a smile, a hug, and good conversation.

Besides living so close by, my grandmother, mother-in-law, and aunt have all been part of the OceanView community as residents of Falmouth House. My mother currently resides there. It has been a wonderful resource for us and our family members to find a vibrant, welcoming, and supportive community so close by.

Children and students across Falmouth have had countless opportunities to engage with, learn and grow from relationships with residents throughout the OceanView community through a variety of intergenerational programs, including the OceanView Kids' Club, Wisdom Tea, and Senior Teachers.

Twenty-six years ago The OceanView Kids' Club began and since then hundreds of local families, children, and teens have gathered monthly for corn hole tournaments, Halloween parades, intergenerational service projects, and connection.

Additionally, teens from Falmouth High School gather monthly with residents of Falmouth House for conversation and dessert. Wisdom Tea, as the gatherings are called, has been meeting for more than 21 years. 100s of students have been involved.

In the words of Falmouth High School student, Val, "OceanView is such a big part of our community in Falmouth and I think to get connected to it, even if you don't have a relative there, is important. We all take stuff from our conversations with the elders that we are never going to forget."

Another FHS student, Angelina, said, "I really can't imagine my high school career without Wisdom Tea and our schools' relationship with OceanView. It's been such an integral part of my education." And yet another student shared in his college essay, "some of the most important things I learned in high school were in conversation with the residents at Falmouth House."

Through the Senior Teachers program, elementary school classrooms visit the various buildings at OceanView monthly to have their classes on campus with the residents participating and supporting the students. I have heard, on many occasions, elementary school students describe their visits by exclaiming, "going to OceanView is more fun than recess!" Teachers often share that students build confidence through their connections with the residents that they bring back to the classroom.

OceanView is a treasured part of our community and an invaluable resource that has created a place for seniors to flourish and in the process share a wealth of knowledge, wisdom, and life skills with each other and with all of us in the broader community.

We are appreciative of the good neighbor we have in OceanView and support its thoughtful, caring approach to expansion and growth.
