The subject project was let for construction on June 12, 2025, with Seven (7) bids received and opened at the Town Clerk Office, Guilderland Town Hall, 5209 Western Tpk, Guilderland, NY 12084 at 11:00am. The engineer's estimate for the project was \$702,879.80 and the following Seven (7) bids were received:
