RE: Town of Guilderland Comprehensive Plan

Dear Guilderland Town Board,

After reading the draft of the Guilderland Comprehensive Plan, Save the Pine Bush would like to add our comments on the proposed plan. We have attached our detailed comments containing data that supports our comments.

First, we would like to explain why the Pine Bush matters.

The Albany Pine Bush is not just land on the edge of our cities and towns: it is one of the rarest ecosystems on Earth. Fewer than two dozen inland pitch pine—scrub oak barrens remain worldwide, and ours is home to the endangered Karner blue butterfly along with countless other plants, birds, and pollinators that cannot survive anywhere else. Its sandy soils and fire-shaped landscape make it a living reminder of both natural history and ecological resilience.

But the Pine Bush is more than rare: it actively protects the communities around it. Its porous soils soak up rainfall, filtering it down to recharge the aquifer that provides clean, reliable groundwater. Its open forests and native vegetation slow stormwater, buffering neighborhoods against flooding. On hot summer days, it cools the air and provides relief from rising urban heat. This isn't just scenery—it's natural infrastructure, working quietly every day on our behalf.

The benefits to people go even further. Scientists have shown that spending even a few minutes in green surroundings can sharpen memory, improve focus, and ease stress. Walks through landscapes like the Pine Bush measurably lower blood pressure and cortisol, while outdoor play and exploration boost children's confidence, language, and social skills. Long-term research is clear: access to biodiverse natural spaces reduces the risk of heart disease, improves mental health, and even extends life expectancy.

The Pine Bush is also part of who we are as a community. It offers miles of trails for hiking and reflection, programs that teach children about science and conservation, and a landscape that draws visitors from across the region. It is a place where families connect, students learn, and residents find pride in a truly unique natural heritage.

The Albany Pine Bush is a sanctuary of rare beauty, a shield against environmental risks, and a source of health and renewal for all who live nearby. To protect and expand it is to invest in clean water, safer neighborhoods, stronger communities, and the well-being of generations to come.

Here is a summary of our comments; the page numbers note where the detailed information can be found:

- 1. The Comprehensive Plan should call for the town to prioritize development outside of the Albany Pine Bush Study Area. Prior to 2000, less than 50% of the Pine Bush area in the Town of Guilderland was developed. Today that number stands at nearly 54% (detailed comments, page 1-5, with maps showing land use).
- 2. The Comprehensive Plan should note that Guilderland contains the single largest portion of the Albany Pine Bush Study Area, totaling roughly 5,600 acres though more than 53% of that land has been developed. We think this is a noteworthy fact that belongs in the Comprehensive Plan (detailed comments, page 6, with chart).
- 3. While the Town of Guilderland has the largest portion of the Albany Pine Bush it has fallen behind other municipalities in preserving Pine Bush Lands as of now, according to GIS data obtained by Save the Pine Bush from the Albany Pine Bush Commission (detailed comments, page 6, with chart).
- 4. The Comprehensive Plan should include the preservation recommendations of the Albany Pine Bush Preserve Management Plan ("Vision Plan") (detailed comments, page 7).
- 5. We believe that the plan should recommend all full protection areas have the long-term goal of becoming dedicated preserve. In addition, all of the ares recommended for partial protection should also be preserved in full. (detailed comments, pages 7-13, with charts and maps).
- 6. In an effort to build in the vision of the Albany Pine Bush Commission, and reflect current land use, Save the Pine Bush used National Land Cover

Dataset data from the Multi-Resolution Land Characteristics (MRLC) Consortium to locate all parcels in the Town of Guilderland, within the Albany Pine Bush Study Area which contain more than two acres undeveloped.

We wanted to not only locate parcels that were fully undeveloped, but those which contain a substantial area of land that is currently Pine Bush or restorable to Pine Bush. With a few exceptions, most of these lands are contiguous or connected to preserved Pine Bush Lands. All of these lands should be preserved (detailed comments, pages 14-30, with charts and maps).

- 7. Save the Pine Bush believes that Guilderland Comprehensive Plan should call for protection of all notable natural communities within the Albany Pine Bush Study from further lost (detailed comments, page 31).
- 8. The Comprehensive Plan should call for the preservation of areas within the Study Area that contain Colonie Fine Sands, that are most conducive to Pine Bush Habitat restoration (detailed comments, page 32).
- 9. The Comprehensive Plan proposes to create a "town center" at the intersection of Western Avenue and Route 155. Save the Pine Bush believes that no further development should be allowed in the Pine Bush north of Western Avenue. Any development of a town center should be forbidden in the Pine Bush.




Save the Pine Bush Detailed Comments on the Guilderland Comprehensive Plan August 18, 2025





Every five years, the Albany Pine Bush Commission as part of their Management Plan issues recommendations for preservation of parcels that are essential for the preservation of the Albany Pine Bush. They refer to it as their Vision Plan, last released in 2017. Here is the breakdown of the plan based on municipality.

We note the plan suggests 767 acres in Guilderland be designated for Full Protection, 508 acres as Partial Protection and 347 acres as Open Space. We suggest the Guilderland Comprehensive include such recommendations in the plan.

On the next page, you will see the Albany Pine Bush Commission's recommendations as it applies to the Town of Guilderland. You can find an interactive version of this map at savethepinebush.org/map.

Specifically, you should note the recommendations of the Albany Pine Bush Commission for Full Protection of all large undeveloped areas north of the Thruway in Guilderland along Curry Road along with several parcels directly to the south of the Thruway along East Lydus Street. We concur that these parcels are critical for long-term integrity of the Pine Bush. We believe that the plan should recommend all full protection areas have the long-term goal of becoming dedicated preserve.

However, we respectfully disagree with Albany Pine Bush Commission regarding the importance of the lands south of Pinehaven Golf Course and Gade Farm. While the Commission recommends Partial Protection of these lands, it ignores the potential connectivity to preserved Pine Bush that currently exists along Hunger Kill, across East Old State Road. Much of this land is wetland and is undevelopable, but other portions are Colonie Fine Sand and should be viewed as required to have sufficient acreage of Pine Bush.


Areas in Guilderland Recommended for Full Protection by Albany Pine Bush Commission.



Save the Pine Bush believes that Guilderland Comprehensive Plan should call for protection of all notable natural communities within the Albany Pine Bush Study from further lost. Specifically we note there is:

The Comprehensive Plan should call for the preservation of areas within the Study Area that contain Colonie Fine Sands, that are most conducive to Pine Bush Habitat restoration. Lost of these areas will forever make it impossible to restore the Pine Bush to a sustainable ecosystem. While historically 3,128 acres of the Study Area in Guilderland was Colonie Sands, only 1,606 acres remain undeveloped including lands already within the preserve. Notice how important the lands north of the Thruway along Curry Road are for protecting the Pine Bush.
