

ORDINANCE NO. 2023-2061

AN ORDINANCE AMENDING SECTION 6-27 REGARDING TEMPORARY CLASS B FERMENTED MALT BEVERAGE AND/OR TEMPORARY CLASS WINE LICENSE

NOW THEREFORE, the Common Council of the City of Mauston does hereby amend and ordain Sec. 6-27 of the City of Mauston Code of Ordinances as follows:

Sec. 6-27. Temporary Class B fermented malt beverage and/or temporary Class B wine license. Applications are to be completed on forms provided by the state Department of Revenue and must be received a minimum of 15 days prior to the granting of the license, per Wis. Stats. § 125.04(3)(f).

In addition to all statutory requirements, the following requirements shall be fulfilled for each temporary class B fermented malt beverage and/or temporary class B intoxicating liquor (wine) license.

1. **Signs.** All organizations issued a class B license shall post, in a conspicuous location at the main point of sale/distribution and at the point of entry, a sufficient number of signs stating that no fermented malt beverage shall be served to any underage person or to any person without proper identification.

~~Fencing. Unless otherwise permitted, all organizations shall install a fence around the area where fermented malt beverages are to be sold and consumed. No sale or consumption of fermented malt beverages shall be permitted outside of the fenced area and no underage person shall be permitted within the fenced area unless such underage person is accompanied by his parent, guardian or spouse who has attained the legal drinking age. The organization shall also continually station a person at the entrance of the fenced area for the purpose of checking age identification. There shall be only one point of ingress and egress, and the fence shall be a minimum of four feet high. If consumption is to occur indoors, a fence shall be used unless persons under the legal drinking age are not permitted to enter the building.~~

2. **Fencing.** All organizations shall install event boundaries where alcohol is to be distributed/sold by the use of signs, barricades, or other approved means when the event is outside or in a temporary structure to control ingress and egress.
3. List of licensed operators.

Outdoor consumption. When an organization requests a license for an outdoor area, the application shall identify the location and size of the ~~fenced-area~~ where alcohol is to be distributed/sold and the organization shall work closely with the police department in locating and setting up the boundaries. At events with projected attendance exceeding a threshold adopted by the Common Council from time to time, participants of legal drinking shall be required to wear a wristband provided by the event sponsor in order to purchase or consume alcohol.
