**RESOLUTION #22-71**

**A RESOLUTION AUTHORIZING A CONTRACT WITH HIGH GROUND  
TRAINING GROUP FOR THE NOLENSVILLE POLICE DEPARTMENT**

**WHEREAS**, the Nolensville Police Department strives to continue training to stay diligent in their skills as well as adapting to new approaches for a changing world; and

**WHEREAS**, Sniper Pro Shop/High Ground Training Group (SPS/HGTG) provides exceptional and affordable law enforcement special operations firearm and instructor training that will help the NPD to continue to effectively protect and serve the community; and

**WHEREAS**, SPS/HGTG has provided the NPD with a purchasing agreement for their proprietary Agency Training & Consultancy Service Program training curriculum; and,

**WHEREAS**, the proposed training agreement supports the NPD's strategic plan and mission to provide high quality enforcement that meet the needs of the community; and,

**WHEREAS**, the Nolensville Police Department recommends approval of this agreement, under those terms and conditions set forth in the contract attached to this Resolution; and,

**WHEREAS**, the approval of the attached agreement would promote the public health, safety and welfare by providing cost-effective quality training for Nolensville police officers; and,

**WHEREAS**, the total purchase price for the training is \$19,950.00 with half of the purchase price (\$9,975.00) being due upon signing of the contract and the second half (\$9,975.00) being due on or before January 2023.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS  
OF THE TOWN OF NOLENSVILLE, TENNESSEE, AS FOLLOWS:**

**SECTION 1.** The Board of Commissioners hereby authorize the Mayor to enter into a contract with Sniper Pro Shop/High Ground Training Group (SPS/HGTG) for their proprietary Agency Training & Consultancy Service Program training curriculum for the Nolensville Police Department (NPD) at a cost not to exceed \$19,950.00.

**SECTION 2:** Half of the purchase price (\$9,975.00) will be due upon signing of the contract and the second half (\$9,975.00) will be due on or before January 2023

**SECTION 3.** SPS/HGTG will provide a scheduled rotation of training and consultancy services to the NPD on a contractual basis with an open agreement of termination by both parties for the FY 2023.

**SECTION 4.** The contract is attached to and made part of this resolution.

**SECTION 5.** This resolution shall take effect immediately, the public welfare requiring it.
