A RESOLUTION OF THE TOWN OF THOMPSON'S STATION, TENNESSEE IN SUPPORT OF THE TENNESSEE DEPARTMENT OF TRANSPORTATION (TDOT) SR-6/US-31 WIDENING PROJECT AND RECOMMENDATION TO TDOT ADD THIS PROJECT THE ANNUAL 3-YEAR PLAN

- **WHEREAS**, the Tennessee Department of Transportation (TDOT) has identified SR-6/US-31/Columbia Pike for a widening project, split into multiple phases; and
- **WHEREAS**, the Town's Major Thoroughfare Plan, as updated, ranks the widening of SR-6/US-31/Columbia Pike as a Top Priority; and
- **WHEREAS**, the Town understands that, as a state route, SR-6/US-31/Columbia Pike widening is a TDOT-led project; and
- **WHEREAS**, TDOT has produced Technical Reports for the 3-phases of the widening project as part of the process to develop a preliminary design for this widening project; and
- WHEREAS, the traffic congestion on SR-6/US-31/Columbia Pike is an ever more critical detriment to the quality of life for residents of the Town, particularly south of the intersection of SR-6/US-31/Columbia Pike and Critz Lane; and
- **WHEREAS**, the traffic congestion on SR-6/US-31/Columbia Pike hampers economic development along a critical corridor within the Town; and
- **WHEREAS**, the traffic congestion on SR-6/US-31/Columbia Pike is a regional issue, as identified by the Nashville Area Metropolitan Planning Organization, which requires action by TDOT; and
- WHEREAS, addressing the increasing congestion, particularly south of the intersection of SR-6/US-31/Columbia Pike and Critz Lane, which is included in the TDOT project identified as PIN 124786.00 State Route 6 (US-31, Columbia Pike) from Duplex Road in Spring Hill (LM 33.00) to near Tollgate Boulevard in Thompson's Station (LM 5.76) in Maury-Williamson Counties, is of critical importance to the citizens and property owners of the Town of Thompson's Station; and
- **WHEREAS**, this Board of Mayor and Aldermen has determined this TDOT widening project is in the best interests of the citizens and businesses of Thompson's Station, Tennessee, and the Town hereby provides full support of this project and recommends that it be added to TDOT's annual 3-Year Plan.

NOW, THEREFORE, BE IT RESOLVED by the Board of Mayor and Aldermen for the Town of Thompson's Station, Tennessee, meeting in regular session on the 10th day of January, 2023, that the Town provides full support of the SR-6/US-31/Columbia Pike widening project and requests that TDOT the project identified as PIN 124786.00 State Route 6 (US-31, Columbia Pike) from Duplex Road in Spring Hill (LM 33.00) to near Tollgate Boulevard in Thompson's Station (LM 5.76) in Maury-Williamson Counties to TDOT's annual 3-Year Plan.

BE IT FURTHER RESOLVED, that this Resolution shall take effect immediately upon passage, the public welfare requiring it.
