Town of Thompson's Station Board of Mayor and Aldermen Meeting Minutes November 7, 2022, 6:00 p.m.

Call to Order:

The meeting of the Board of Mayor and Aldermen of the Town of Thompson's Station was called to order at 7:00 p.m. on November 7, 2022. Members and staff attending were Mayor Corey Napier, Alderman Shaun Alexander, Alderman Brandon Bell, Alderman Brian Stover, Alderman Andrew Zinn, Town Administrator Ken McLawhon, Town Planner Micah Wood, Maintenance Supervisor Brian King, Wastewater Operator Kenny Bond, Town Clerk Regina Fowler and Town Attorneys Andrew Mills and Kirk Vandivort.

Pledge of Allegiance:

Mayor Corey Napier and Brandon Bell were presented with railroad spike plaques for their service to the Town of Thompson's Station. The Town Staff appreciates their years of leadership, loyalty, and dedicated service to the Town. We wish them well.

Approve Consent Agenda:

Alderman Brandon Bell made a motion to approve the Consent Agenda. The motion was seconded by Alderman Brian Stover and carried 5 yay 0 nay.

Announcements: Alderman Brian Stover requested updates on Bridgemore and Critz Lane. There are 24 days left on the Bridgemore project and the forbearance agreement is in effect through 12/1/2022. We are under the assumption the project will not be completed in time. Our legal team has been in contact with their legal team, and they are fully aware of the deadline and the calling of the bonds if in fact the project is not completed. We will update you on 12/2/2022. According to an Alderman in regard to Critz Lane, both signs on highways 31 & 431 are not working and we should not be billed for incomplete signage. The Town Administrator noted that this situation will be brought before RaganSmith.

At the January 10, 2023, BOMA meeting Mayor Brian Stover and Alderman Bob Whitmer will be representing the Town of Thompson's Station. There is one open Alderman position that will need to be filled for a two-year term. Per the Town Charter and TN State Law, BOMA members

will submit their nominations and there will be a voice vote process once nominations are closed. Per Board discretion, once the Board goes through the nomination process, close the nominations, perhaps BOMA would allow the nominees a pre-selected time to address BOMA. BOMA members may want to invite their nominee to be present if they wish to address BOMA. The Board will conduct a roll call voice vote on the nominees (exact procedures will be sent to BOMA prior to the meeting) and the vote will be determined by the majority. If a selection is determined that individual would be sworn in by the new Mayor and begin immediately.

Per the Town Administrator and BOMA discretion, an interest form for other vacant advisory board/committee positions can be added to the Town's website for an individual to complete should they have interest in a vacant position. The forms could be available for BOMA perusal with the understanding that this is strictly an interest form and not a formal nomination. BOMA members would be required to make a nomination for any vacant position.

Public Comments:

Harry King - 3684 Rondstadt Road: He would like clarification on the Bridgemore Project bonds being called. He would like to thank Mayor Napier and Alderman Bell for the job they have done. He would also request the red light at Highway 31 and Thompson's Station Road be reduced in the amount of time the light stays green in the North and South bound lanes.

At the request of the Town Administrator, Legal Counsel was asked to discuss the forbearance process for Bridgemore. On December 2, 2022, the Town Engineer would complete a punch list for any incomplete items. Town Staff would secure funds from the securities. The Town Engineer would then complete a bid document for the incomplete items.

Unfinished Business:
